Condé Nast College of Fashion & Design is changing its name to Vogue College of Fashion on 30th September 2024. From there on we will refer everywhere officially to the College as Vogue College of Fashion including your final diploma and certificates obtained at the point of graduation with the College post 30th September 2024

Our Contract with You

This document sets out the terms and conditions between Condé Nast College of Fashion & Design – London (the College) and students on our Undergraduate programmes. It contains important information and you should read these terms and conditions carefully before accepting your offer to ensure that you understand the contents, as these terms and conditions, together with other policies and procedures of the College, will become binding on you and us when a contract is formed between us.

These terms and conditions govern the relationship between you and the College. By accepting the College's offer of a place on a Programme of study, you accept these terms and conditions in full, which, along with your offer and the College's rules, regulations, policies, and procedures, form the contract between you and us.

These terms and conditions will become binding on you and us when you accept the College's offer of a place by accepting the offer, confirming your details, and paying the Deposit or full fees depending on the course requirements, and any conditions set out in your offer have been met to our satisfaction. At this point, a legal contract is formed between you and the College on the basis of the terms and conditions set out in your offer letter, the terms and conditions set out in this document, and the terms and conditions set out in the policies and regulations listed in the Student Handbook and on our website (available [here](#)).

and any other policies and regulations which the College may bring into force during your registration as a student. Please see our website [here](#).

You will not be able to start your studies at the College until we have received by an agreed deadline:

- (1) your acceptance
- (2) your non-refundable deposit payment
- (3) the required 1st instalment of your course fees and/or full fees depending on the course
- (4) presentation, in person, of your passport and valid visa documentation where required

The College reserves the right to require you to withdraw from a programme at any time should you fail to pay any part of your fees.

The Validating University

The undergraduate courses delivered by Condé Nast College of Fashion & Design – London are validated and awarded by the University of Buckingham, and therefore upon completion of your degree you will receive an award from the University of Buckingham.

The academic regulations that govern the delivery of your programme can be found on the website of the University of Buckingham [here](#) (Section 3).

In the event of a conflict between these Terms and Conditions and the academic regulations, policies and/or procedures of the validating university which apply to your studies, the academic regulations, policies, or procedures of the validating university shall take precedence.

Enrolment and Re-enrolment

Your place on a programme of higher education with the College will be conditional on you complying with the relevant conditions and requirements, as explained in this

document and your offer letter, and enrolling at the start of your course and at the start of each subsequent academic year.

You must enrol at the designated session at the start of your programme, as set out in your introductory information and induction pack provided by the College. If you cannot or do not enrol at the designated session, you must provide the College with a reason for your non-enrolment that is acceptable to the College, otherwise you will not be entitled to enrol for that year of study (or any future year of study) and your relationship with the College, and this contract, shall be terminated.

Provided you are eligible to re-enrol (which means you have met the assessment and progression requirements, do not owe any tuition fees and have not been suspended from the programme for any reason), you must re-enrol for each subsequent year of study using the approved procedure.

Tuition Fees and Other Costs

Tuition Fees cover all lectures, seminars, teaching activities, and practical sessions. The cost of housing, meals, and all other personal expenses are your responsibility. Tuition fees are reviewed annually; however, fees will not be amended from those advertised after your offer of a place has been confirmed.

You will be expected to cover the costs of your accommodation, transport to and from the campus, as well as meals throughout the time of your studies with us. We recommend a minimum of £ 1,300.00 - £1,400.00 per month.

Optional New York Trip (only programme): If you are enrolled on one of our MAs, we offer the opportunity to join an optional 4-day long College trip to New York City, usually during the Spring term; the cost of the trip will be communicated to eligible students in the first term - we estimate that this will cost in the region of £1,200.00 - £1,500.00, which will cover flights, transfers in the USA, accommodation and any museum or exhibition entry fees that are part of the itinerary.

Please note that foreign visits may require separate visas. It is the individual student's responsibility to ascertain whether a visa is necessary and to make sure the correct visa is obtained well in advance of study trips. Programme Coordinators can provide supporting letters if necessary.

Adobe Creative Suite: You will be required to have an ACS student license, currently £19.00 per month.

Optional Graduate Exhibition (and Foundation students only): Every student completing one of our or Foundation programmes will have an opportunity to showcase their work to the external world during the annual Graduate Exhibition in a bid to gain better professional exposure and opportunities. Exhibiting students in the past have produced work and displays of professional quality, from Marketing Strategies through to the whole business concepts with samples of their products; as such, the costs involved are very individual and will vary from student to student. Most students should expect this to cost between £300.00 - £1000.00, although this figure could be lower or higher sed on the type of project.

Fee levels and increases

The annual levels of programme fees for students shall be set annually and published on our website applicable to that year of entry, and may increase in subsequent years - the tuition fees confirmed in your offer letter are fixed for the original duration of your studies.

Programme fees for students may increase in subsequent years, linked to the Retail Price Index. Such increases will be no more than 2% above the Retail Price Index.

Students who intermit their studies and return in a new academic year that falls outside the normal two-year registration period for this programme are charged at the same rate as new students in the year they return. This may lead to an increase in the amount you are required to pay overall for the tuition fees. Where a student returns from intermitting their studies with no tuition outstanding, there will not be any increase in any outstanding programme fees.

Payment Methods for Programme Fees

Payment should be made via our approved payment provider Flywire. Further details about the methods of payment are included in the Payment section of this document.

Should you fail to pay any part of your fees after receipt of a final notice from us, the College reserves the right to withdraw our offer.

Cancellation and Withdrawal

Cancellation by You During the Cooling-off Period

You have the right to cancel your contract with us for any reason in writing within 14 days ("Cooling-Off Period"), starting the following day on which the contract is entered into and at least 7 days prior to the programme start date. In such event, the College will refund all your fees paid, including the deposit paid (except where the programme commences within seven days following the date of acceptance, in which case you will be deemed to have enrolled and your refund, if any, will be governed by the terms set forth under "Withdrawal by You other than during the Cooling-off Period").

To exercise the right to cancel, you must inform us before the end of the Cooling-Off Period by emailing us directly at admissions@condenastcollege.ac.uk with a clear statement communicating your decision to cancel this contract. Where the Cooling-Off Period would normally end on a day which is a Saturday, Sunday or a public holiday, the Cooling-Off Period will be extended so that it ends on our next working day.

The College will make the refund using the same means of payment as you used for the initial transaction unless you have expressly asked us and we have agreed otherwise; in any event, you will not incur any fees as a result of the refund.

Withdrawal by You (Other than During the Cooling-off Period)

The College will refund your programme fees in full, minus the non-refundable deposit fee,

if your notice of withdrawal is received in writing at least six weeks prior to the first day of your Programme. The College does not normally refund programme fees after this time. If you withdraw during the period commencing six weeks prior to the first day of your Programme, but outside the 14 day Cooling-Off Period, and ending at the end of the fourth week of Semester One, you may apply for a partial discretionary programme fee refund on exceptional grounds. To apply, you must write to Admissions at admissions@condenastcollege.ac.uk, providing an explanation for your withdrawal and reasons why yours should be considered an exceptional case. You should include supporting documentation, if any. The College will consider the appeal and its decision will be final. If you defer your enrolment to the next academic year during this period, after paying the deferral fee, the College will refund your programme fees in full, minus the deposit.

If you choose to withdraw during the programme after the fourth week of Semester One, you will not be entitled to any refund.

Involuntary Withdrawal

If you are asked to leave the programme as a result of failing academic work, disciplinary issues, non-payment of fees or non-attendance, as outlined in our policies and in the student handbook, the College will not refund any fees to you.

Withdrawal Due to Visa Issues – Non-UK Students

You are responsible for ensuring that you have the appropriate visa to enable you to study in the UK, and the rejection of a visa application by UK Visas and Immigration does not affect the application of these terms and conditions. The College recommends that all applicants check with the British Emssy or British High Commission regarding their visa requirements before applying. If you are unable to obtain a visa and have supporting documentary evidence to show this, you can apply in writing to the Admissions Team Committee at admissions@condenastcollege.ac.uk to be considered for a refund of programme fees already paid (minus the deposit) as per the section entitled “Withdrawal by you other than during the cooling off period”, unless:

- You applied for a visa that does not make you eligible to study in the UK on a course of study that leads to a qualification at level 7 of the Regulated Qualifications Framework (RQF) for a duration of nine months for the Postgraduate Diploma or twelve months for the MA.
- The visa was refused due to fraudulent activity on your part or if you provided incorrect information.

Termination Rights

We may terminate this contract and your application to the College, or registration as a student, with immediate effect in writing in any one or more of the circumstances identified below:

- If you fail to pay your tuition fees to us by the specified due date for payment, and where you fail to make good your debt;

- If you do not meet any of the conditions set out in our offer to you, or if you cease to meet any of those conditions after the contract is formed;
- If you do not enrol or re-enrol onto your programme by the relevant enrolment or re-enrolment date;
- If it becomes apparent that the information you have provided to us during your application, or at any stage during the term of this contract, is incorrect or misleading, including by omission of material information;
- If you fail to comply with conditions associated with your immigration status;
- If your continued registration with the College places the College in breach of any of our legal obligations, including under UK immigration law;
- If a decision is made to terminate your studies / registration as a student (or you are otherwise required to exit) on grounds relating to your conduct or fitness to study, for example, under the Student Code of Conduct;
- If you are in material breach of these Terms and Conditions, and/or any of the College's regulations, policies, procedures, or codes of conduct that form part of this contract;
- If you fail to progress academically in your programme in accordance with the College's regulations;
- If you fail to satisfy the College's attendance requirements;
- If you fail to return from a period of interruption from study;
- If your behaviour, in our reasonable opinion, represents a significant risk to the health, safety or welfare of yourself or other students, staff or members of the College's community.

If we terminate this contract pursuant to this section, you remain liable for any outstanding tuition fees or costs owed to the College to the date of termination. The College may at our discretion refund some or all of your tuition fees. The College will not be liable for any loss or damage of whatever nature which you may suffer as a result of any action taken against you by the College to terminate the contract, including where we terminate the contract as a result of disciplinary action taken by the College (provided the action by the College is not negligent and is taken properly in accordance with the contract and the relevant procedures).

Deferral of Enrolment

If you wish to defer your offer to study to the next academic year you must first accept the offer of a place in the intake you applied for by completing a non-refundable deposit payment. Failure to do this will mean that your place is not booked and you will need to re-apply for the next intake if you wish to join us in that academic year.

Following receipt of the Deposit payment, a deferral request can be submitted to admissions@condenastcollege.ac.uk with your name, applicant ID, course you applied to, and the reason for deferral.

The Deposit will be held and deducted from programme fees in the following intake only. Deferral may only be granted once. Deferral of a place over more than one academic year is not permitted – if you are unable to take up the place in the following intake to that which you applied, the College will retain the Deposit, and you will need to submit a new application should you wish to be considered for entry.

Please note that you will have to pay any increase in tuition fees for the year in which you will join the programme. Any conditions listed in your offer must have been met before the deferral takes place.

Transfers Between Programmes

Because of UK visa regulations, students on a Student Visa who wish to transfer to another programme at the London campus may request this only before they have initiated their visa application. After this, they will be unable to switch programmes.

Other students who wish to transfer to another programme at the London campus may request this up to the end of the second week of the programme for consideration by the Admissions and Academic teams.

Offer-holders interested in transferring between programmes should contact Admissions at admissions@condenastcollege.ac.uk in the first instance to discuss their options. In order for any such transfer to be considered, students will then be required to submit a formal request to the relevant Programme Director providing a rationale for the transfer. No transfer will be final without the agreement of the Programme Directors of each programme.

The Programmes

The College aims to ensure that the student learning experience, as described on the website and student handbooks, is delivered and maintained at all times. In some circumstances, the College may have to vary the method of delivery of your programme, and in some cases, the syllabus may be altered or updated. In the unlikely event that the College discontinues your programme or changes it significantly whether before you start your programme or once you have begun, we will tell you at the earliest possible opportunity. If this happens before you start your course, you may wish to withdraw your application; if you do so, the College will provide you with support and guidance in finding an alternative programme either at the College or at another UK university. Please also see the section Programme Changes, Cancellation and Suspension for more detailed information.

Events Outside of Our Control

We shall not be liable to you for events outside our control which we could not have foreseen or prevented, even if we had taken reasonable care. Such events include, but are not limited to:

- severe weather, fire, flood, storm, tempest, explosion, earthquake, subsidence, or other natural disaster;
- civil commotion, riot, invasion;
- an actual, suspected or threatened act of terrorism;
- war (whether declared or not) or threat or preparation for war;
- pandemic, epidemic or local health emergency necessitating measures to reduce

- the risk of illness;
- restrictions imposed by government or public authorities;
- national emergencies;
- failure of public utilities or transport systems;
- failure of public or private telecommunications networks.

Should any such circumstances arise, we reserve the right to change or cancel parts, or all, of the programme. We will take reasonable and proportionate steps to mitigate any adverse impact on you.

Subject always to the previous paragraph, the College will make all reasonable efforts to deliver your programme as described in the College's prospectus. There may be occasions where due to unforeseen or unavoidable circumstances it becomes necessary to make significant changes to a programme or to withdraw it or part of it, e.g. a particular unit/elective. Such action could become necessary if, for example, the following were to occur:

- to reflect changes in the law and/or regulatory and/or professional and/or statutory body requirements and sector regulation;
- as required by law, government policy, regulatory requirements or guidance and/or a decision of a competent court or similar body;
- to comply with any requirement set by the Home Office, Office for Students and/or any other funding or regulatory body;
- changes have to be made to reflect changes in standards set by relevant regulators and/or in keeping with best practices or developments related to the particular discipline/subject area;
- to deal with unavoidable changes in our academic and support staff;
- to reflect material developments in academic teaching, research and /or professional standards or requirements to ensure our course/programme content is up-to-date and relevant;
- student feedback, External Examiners' feedback or Programme Review clearly indicates that immediate changes be made to a course or unit;
- an unanticipated external event or issue with the buildings results in disruption to delivery;
- unexpected low recruitment to a programme/course or unit/elective means it is simply no longer viable or practical to run it;
- withdrawal of relevant accreditation.

In the event that the College has to make such material changes to a programme, as described above, it will make students aware of these changes as early as possible and highlight if the College's Refund and Cancellation Policy applies. You can find this policy [here](#).

Programme Changes, Cancellation and Suspension

Programme Changes

If it reasonably considers it to be necessary, the College may make reasonable changes to the content, syllabus, mode of assessment, and/or timetable of your programme which:

- are not material to the overall learning outcomes of the programme (for example, moving the timing of a particular module);
- will benefit the training of you or other students (for example, enabling you or other students to benefit from additional classes with visiting professionals);
- are caused by matters outside of our control, as set out above under 'Events Outside of Our Control'; and/or
- are in order to comply with changes in the law or, as applicable, the instructions of higher education regulatory bodies, the validating university, and/or any professional/statutory body.

Where changes to be made to programmes are not significant, the College will consult the affected students and will take all reasonable steps to notify you at the earliest opportunity and to minimise any disruption to your studies.

The College defines 'significant changes' to a programme of study as changes requiring full approval by the validating university, such as changes to the award, core modules or delivery mode. In the unlikely event that a programme is changed significantly:

- the College will consult the affected students and will take all reasonable steps to notify you at the earliest opportunity, and to minimise any disruption to your studies;
- you will be entitled to withdraw from the programme by informing us of this intention in writing;
- if you withdraw from your programme, the College will refund programme fees and deposits paid in accordance with the Refunds and Cancellation Policy (please note that refunds may be calculated on a pro-rata, and
- we will provide you with support and guidance in finding an alternative programme either at the College or at another UK provider.

Programme Cancellation and Suspension

The College may cancel or suspend programmes if there are insufficient numbers of student enrolments to make a programme viable, or for any reason outside the College's control. Where relevant, the College's Student Protection Plan may apply. In the unlikely event that the College cancels or suspends your programme, in consultation with the validating university:

- the College will consult the affected students and will take all reasonable steps to notify you at the earliest opportunity, and to minimise any disruption to your studies;
- the College will review the decision in accordance with the applicable Student Protection Plan to determine appropriate refunds of programme fees and deposits paid (please note that refunds may be calculated on a pro-rata, and;
- we will provide you with support and guidance in finding an alternative programme either at the College or at another UK provider.

Other than refunding your fees, the College accepts no liability for expenses or losses you or any third party may incur because of a programme's cancellation or suspension.

Online Programme Delivery

Where programmes, or parts of programmes, are made available to you through the Internet, you acknowledge that you have access to the relevant IT equipment, internet

speed and capacity to participate in the delivery of the programmes. Additionally, given the nature of the internet, the College cannot guarantee that access to the Programme will be uninterrupted or error-free. You also acknowledge and accept that the College cannot guarantee that materials and other information downloadable or printable from the Programme can be downloaded or printed within any specified period.

Face-to-Face Delivery

In the event that face-to-face teaching needs to be modified, reduced, or cancelled, due to health and safety concerns and government or other regulatory guidance and/or requirements, the College reserves the right to prioritise the continuity of teaching using remote online methods, with the aim of both ensuring that student learning outcomes continue to be met and the facilitation of timely completion of degree programmes. If this takes place, the College shall not be liable to students for refunds or compensation where it has delivered its obligations to students in alternative ways in such circumstances.

Students with Disabilities

Condé Nast College of Fashion & Design - London welcomes applications from students with disabilities and learning differences and undertakes to make reasonable adjustments in order to accommodate them. To be able to do this it is helpful if students let us know about any disabilities or learning differences they have as early as possible during the application process or email us at admissions@condenastcollege.ac.uk. Condé Nast College is located in a historic Georgian building at Bedford Square in Central London. Our campus comprises a Grade I listed building dating to the late 18th Century which is currently not fully accessible to wheelchair users. International Students

Condé Nast College of Fashion & Design - London is a UK Visas and Immigration (UKVI) approved sponsor of International Students. As such, the College is obliged to operate within the requirements of the relevant Immigration legislation and formal regulations for Sponsors. These include:

- ensuring that a record of passport and visa documentation is held for each international student;
- ensuring that contact details are maintained and up to date for every student;
- ensuring that students are meeting the attendance criteria for their Programme of

study, and

- reporting any non-compliance to the UKVI within their mandatory timescales.

If you are an international student who requires formal student visa entry clearance from the UK authorities to enter or remain in the UK for the purpose of undertaking study, there are obligations you must meet as a student at this College, described in the following sections.

When You Arrive at the College to Start Your Programme of Study:

- You will be invited to attend a face-to-face enrolment session which you must attend bringing with you your passport and your visa documentation for inspection. Only original documents will be accepted. The College is required to take and retain a copy of those documents for its records.
- You will not be able to fully enrol on your Programme of study until you have satisfied this requirement.
- If you do not have your full documentation you must still attend the face-to-face session and provide evidence of your progress with the visa process.
- Failure to produce the required documentation within 4 weeks after the Programme start date may lead to the cancellation of your place at the College and your non-compliance being reported to the UKVI.

During Your Programme of Study:

- You must enrol at the start of the academic year and make suitable arrangements to pay any fees due, in accordance with the Tuition Fee payment schedule.
- You must inform the College of any changes to your personal and/or academic circumstances which might have an impact on your visa status, including any part-time employment during term time.
- Any change of your address, visa status or passport details must be reported promptly by you to the College by emailing admissions@condenastcollege.ac.uk.
- You are responsible for ensuring that your visa remains valid from the commencement of and for the duration of your Programme and that you apply for any necessary extension/renewal in good time.
- You will be expected to meet all the attendance and submission dates relevant to your Programme of study.
- Failure to comply with these requirements may lead to your suspension from the College and ultimately the cancellation of your place on a Programme at the College with your non-compliance being reported to the UKVI.

Insurance

Non-UK students are required to have adequate health, accident, disability, and hospitalisation insurance to cover themselves during their time at the College. Students recognise and accept that no part of the course fee goes toward payment of such insurance and that the College has no obligation to provide such insurance.

Age Requirements

Age requirements for our courses are based on academic age; this is an

applicant's/student's age on the 1st of September, the start of each academic year. An academic year runs from 1st September – 31st August annually. For the duration of the academic year, a student is considered to be their academic age for admissions purposes, regardless of when their birthday falls within that academic year.

For all our degree courses, students must be aged at least 18 years old on 1st September at the start of the academic year in which they intend to join their chosen course. By submitting your application, you agree that you will be aged 18 or over on this date. If this proves to be incorrect, we may terminate our agreement with you, and you will not be entitled to a refund.

Student Conduct

Students are expected to conduct themselves in a professional manner and to recognise that other students also require support and assistance.

If a student becomes persistently disruptive, we reserve the right to issue a verbal or written warning and, if this does not resolve the situation, the College's formal non-academic misconduct procedures will be invoked, which may result in the student being withdrawn from the course. In such circumstances, no refund of any course fees will be due.

By enrolling in any course offered by the College, students agree to comply fully with the disciplinary rules of the College and to abide by our Student Code of Conduct, which can be accessed [here](#). In addition to compliance with the disciplinary rules of the College, we require that students maintain a good attendance record, rigorous respect for the schedule of lessons, and a responsible attitude towards the College staff and facilities. Failure to adhere fully to these rules may result in disciplinary measures being taken against the offending student.

Students understand that should they have legal or medical problems while they are enrolled at the College, they will attend to the matter personally and with their own funds. They accept that the College will not provide any personal or financial assistance.

Conditional Acceptance

A student's place will be subject to the student meeting any offer conditions that the College shall notify the student in writing such as obtaining particular qualifications and/or satisfying all necessary legal and other requirements to study in the United Kingdom on the chosen course (for example in relation to health checks and immigration clearance).

Payment

Payment of tuition fees must be made via our approved payment provider Flywire.

On your first visit to the Flywire site, you will be asked to create an account which can be used to make all subsequent payments to the College. Depending on where you are making your payment, you will be presented with a variety of ways to pay, which will usually be expressed in terms of your local currency. In most cases, this will include the

option to make a domestic bank transfer or pay by credit/debit card.

Please note:

You must ensure that you complete the student information details in full, including your student ID, course name and email address in order for us to be able to identify your payment.

Instalments

In order to confirm and secure a place on this course, students will be asked to pay a deposit in the amount of £3,000 at the point of receiving an offer from us.

UK students can pay the tuition fee in instalments throughout the year.

International students will be asked to pay their first instalment of the course fee before they start at the College and prior to the issue of a Confirmation of Acceptance for Studies (CAS).
